 To generate capital appreciation over a long term by investing in equity and equity related instruments.

### The investment approach is as summarised below:

- Rule-based stock selection
- Focus on companies with superior quality over a long period with high ROE and cash rich companies with high dividend paying capabilities
- Preference for companies with lower volatility in returns and avoid loss making companies
- Portfolio would be reviewed for re-balancing on a yearly basis
- Allocation would be 80% to 100% in equity and equity related securities and 0% to 20% in debt oriented mutual funds, cash, liquid funds and arbitrage funds.
